2010 YEARLING FUTURITY

Our 2010 yearling doe futurity is open to anyone willing to abide by the following rules:

1. This futurity is open only to yearling does shown in the 2009 CPGA Weanling Doe Futurity.
2. Send the first nomination fee for each yearling doe of \$5.00 to the futurity chairperson, postmarked no later than Oct. 17th, 2009.
3. Send a \$5.00 intermediate sustaining fee for each yearling doe to the futurity chairperson, postmarked no later than February 17th, 2010
4. Send a \$5.00 final sustaining fee for each yearling doe to the futurity chairperson, postmarked no later than March 17th, 2010, including each doe's registered name, registration number, and date of birth.
5. Futurity doe will be shown in a non-sanctioned futurity class at the CPGA Spring Fair Show in April 2010. The futurity will be judged by the NPGA breed standard; it is at the judge's discretion to give oral reasons for all placings or to limit reasons to the top 5 places. Original registration must be presented at check-in.
6. Futurity doe shown in the Futurity class may be shown in the sanctioned doe show on the same day.
7. Yearling futurity fees collected will be awarded as premiums to the top 5 placements. 1st = 30%, 2nd =25%, 3rd =20%, 4th =15%, 5th =10%. If less than 5 does are shown, the award money for unused placements will be divided equally among those does shown.
8. There shall be no refunds. If fees are not paid on time the entry will be disqualified and fees forfeited. Deadline notices will not be sent. Full refunds will be made only if CPGA is unable to hold its Spring Fair show.
9. If the nominated doe is sold, the futurity rights and fees payable continue to the new owner subject to the rules above. Premiums will be paid to the Yearling doe owner at the time of the show as verified by the Certificate of Registry or the Transfer of Ownership form.
